#### 4. **ELECTION** of 2016-2017 Committee Chairperson and Deputy Chairperson

- A. Dr. Poole thanked Drs. Hoepfl and Bradbury for serving as Committee Chairperson and Deputy Chairperson for 2015-2016. He stated that the appointment was for one year, but that both individuals has indicated that they would serve again if asked.
  MOTION 1: Nominations were opened for the position of Committee Chairperson. Only Dr. Marie Hoepfl was nominated and a motion was made (McCullough) and seconded (Smith) that the nominations be closed and that a vote be taken. Nomination of Dr. Marie Hoepfl as Committee Chairperson for 2016-2017 PASSED.
- B. Chairperson Hoepfl took over the meeting and began with the election of the Deputy Chairperson.

**MOTION 2:** Nominations were opened for the position of Committee Deputy Chairperson. Only Dr. Mark Bradbury was nominated and a motion was made (Shows) and seconded (Abbott) that the nominations be closed and that a vote be taken. Nomination of Dr. Mark Bradbury as Committee Deputy Chairperson for 2016-2017 – **PASSED.** 

The meeting returned to Agenda Item 3: the structure of GAPP and its subcommittees.

#### 3. Brief HISTORY and ROLE of GAPP

A. Chairperson Hoepfl explained that the Graduate Academic Policies and Procedures Committee "merges" the previous Graduate Council and the Graduate portion of the Undergraduate AP&P Committee. Each voting committee member is also a member of either the Curriculum or Policy Subcommittee. The Subcommittees undertake a finer, more detailed approach to the review of proposals to then move them forward to the larger Committee to be put to a vote. The Chairperson and Deputy Chairperson also serve as GAPP representatives on a joint AP&P Subcommittee that reviews and updates policy statements that pertain to both the Undergraduate AP&P and Graduate AP&P Committees. Finally, there is an Awards and Recognition Subcommittee that works to aid the Graduate School in granting fellowships, scholarships, and awards to students and faculty. That Subcommittee will be gathered ad hoc when the award time period approaches in March.

**MOTION 3:** A motion was made (Dentith) and seconded (Stallworth) that a vote be taken on the nomination of Audrey Dentith as the Chairperson of the Awards and Recognition Subcommittee – **PASSED**.

- B. Chairperson Hoepfl thanked all members for their commitment and reiterated that the GAPP is the final approving body for changes to graduate curricula and policies; therefore, members should be vigilant in proposal review. She also explained that there is an AsULearn site where agendas, meeting minutes, and proposals are posted each month. It is an open and public forum that anyone can request to join.
- C. Rob Sanders mentioned that there is also an "as needed, standing" ad hoc committee for any student appeals sent through the School of Graduate Studies.
- D. Chairperson Hoepfl mentioned that Marty Hall creates the agendas and transcribes the minutes of each GAPP meeting for posting. Sharron Grimes receives and posts all submitted proposals. Debbie Race and Patty Dale of the Registrar's Office were thanked for their participation and great attention to detail.

#### 5. APPROVAL OF MINUTES

A. **MOTION 4:** It was moved (Shows) and seconded (Mansure) that the minutes of the April 18, 2016 Grad AP&P Meeting be approved – **PASSED.** 

**Procedural notes:** All dual-listed undergraduate course changes are approved through the Undergraduate AP&P Committee. Except as otherwise noted in these minutes, curriculum and policy motions are made from the respective Grad AP&P subcommittees and do not require a second.

## 6. NEW BUSINESS

**A. Policy Proposals**: These proposals have not been reviewed by the Policy Subcommittee but will be discussed at their first meeting. A lengthy discussion followed, with Associate Dean Sanders answering questions.

## Cratis D. Williams School of Graduate Studies:

G\_GRAD\_2016\_01 1) Change graduate school admissions policy to require applicants to only submit transcripts for degrees earned and any graduate coursework completed within the past five years.

2) Change the Graduate School requirement for official test scores. Test scores would only be required by the Graduate School for applicants BELOW a 3.0 GPA in the last degree earned. Individual programs may elect to continue the test score requirement as one of the factors in the admissions review.

G\_GRAD\_2016\_02 Change language in Graduate Bulletin to clarify policy regarding Double Major and Double Degree. The new policy is intended to provide clearer guidelines on how students may choose to pursue pre-approved dual degree programs of study. The new language will remove any references to distinctions between double majors and double degrees, and refer to any dual program of study as "dual degree."

# QUICK GRADUATE SCHOOL RELATED UPDATES:

# Total University Enrollment (Fall 2016):

- Appalachian total enrollment for the University: **18,295**, up from 17,932 in Fall 2015, an increase of 363, or 2.0%. The target was 18,300.
- Total distance education enrollment is **1,304**, up from 1,227 in Fall 2015, an increase of 6.3%.
- Diverse new student enrollment (for which ethnicity/race is indicated) is **949**, up from 761 in Fall 2015, an increase of 188, or 24.7%

## Graduate Enrollment:

- Total graduate enrollment is **1,700**, up from 1,642 in Fall 2015, an increase of 58, or 3.5%. The target was 1,595. Graduate student enrollment constitutes 9.3% of total enrollment, essentially stable from 9.2% in Fall 2015.
- Total main campus graduate enrollment is **1,102**, up from 1,031 in Fall 2015, an increase of 71, or 6.9%. The target was 1,032.
- Total distance education graduate enrollment is 631, down from 641 in Fall 2015 a drop of -1.6%.

• Under-represented minority new graduate enrollment is **105**, or 13.5% of new graduate students, up from 10.9% in Fall 2015, an increase of 27, or 34.6%.

## Miscellaneous:

- Had 2417 paid applications in 2015-16 (July through June).
- Had over 700 graduate assistantship agreements processed for fall 2016.
- "Graduate Connections" was inaugurated for Fall 2016. The program, in partnership with GSAS, offers a blend of graduate student professional and personal development opportunities with social activities. The purpose is not only to provide P&PD Opportunities for the students but to contribute to building a "graduate student community" at ASU.
  - Rob Sanders announced a Graduate Program Director Meeting (for both new and continuing Directors) is scheduled for Friday, September 30, 2016 in the Plemmons Student Union.
  - 3. The Graduate School has drafted a student survey, which will be broader and more comprehensive than the one sent to alumni after they graduate. In addition, a Graduate School customer satisfaction survey will be sent to faculty and staff about their dealings with the School of Graduate Studies.
