- SW 2. Change the Graduate Bulletin description of the Master of Social Work program to add the offering of Advanced Standing to graduates of social work bachelor's degree programs that are accredited by the Council on Social Work Education.

MOTION: Approve proposals SW1 and SW2 with a change to the proposed bulletin formatting (not content) in SW2 (page 15 of the packet for social work), which will be shared on paper at the meeting.

DISCUSSION:

The Arts & Sciences Council recommends passing the requirements or testing out of courses. Question was asked about who determines whether the student will be required to take up to 6 hours of coursework. The response was that a team of Social Work educators representing the curriculum determines such. An exam is given to determine deficiencies, and additional work is recommended, if applicable.

DISCUSSION:

Many programs on campus use an admission formula for GRE scores in lieu of minimum scores in the respective areas. The Council of Graduate Schools leaves the decision to institutions whether to require the GRE.

Dr. Hirst would like the Council to discuss removing the limit on the number of times a student can enroll for thesis credit (5989). In order to have university privileges, students must be enrolled; they should not have a limit on the numbers of times in which they can register for 5989, although only a specified amount may count toward the Program of Study. Discussions are being held with Financial Aid to determine whether repeated enrollment in 5989 can count toward federal financial aid.

Inactive courses are being removed from the books, courses are merged and repackaged, prefixes changed to reflect the respective content, and courses updated.

Dr. Hirst made note where changes need to be made in the *Graduate Bulletin* and programs which programs will be affected. Dr. Davis asked that Community Counseling be added to the list.

MOTION: It was moved (Harbinson) and seconded (Brewer) that PHY/AST 07-01, PHY/AST 07-02, and PHY/AST 07-03 be approved.

DISCUSSION:

The subcommittee asked the department to 1) discuss the use of the word "engineering" in the title of the degree program; 2) address whether the CIP (classification of instructional programs) code will change; 3) to provide specific examples where this title has been used at a school without an engineering program to provide the multidisciplinary focus implied by the title engineering physics; and 4) to discuss whether there are MS programs rather than ME programs.

Dr. Calamai responded

- the name change will benefit students
- 85% of their graduates get jobs as engineers with engineering titles
- There aren't Engineering Physics degree programs in the UNC System.
- Applied Physics is more engineering-oriented than many around country.
- American Board of Engineering and Technology, accredits engineering programs, does not maintain rights to the title Engineering Physics.
- The CIP will not change. The name change can be submitted via memo.

VOTE: Motion carried to approve PHY-AST 07-01, PHY/AST 07-02, and PHY/AST 07-03Vote:

Dr. Haney requested that Dr. Calamai draft a memo to General Administration explaining the above, after the proposals are approved by AP&P.

Other Curriculum Discussion. Concern was expressed that programs are lowering requirements, e.g., the minimum GPA. It was noted that several years ago some programs were ambitious and set high limits and are now lowering the GPA. School personnel receive salary increases for degrees awarded. These educators bring valuable professional experience to programs. These life experiences are considered in the admission process. Programs are now required to have program evaluations which will provide data on the student success. Many programs now use an admission formula.
