Minutes of the Meeting Held April 21, 2008**

1. Dr. Huntley welcomed members and introduced guests.
2. Minutes. It was moved (Specht), and seconded that the minutes of the March 17 meeting be approved with changes as noted. No abstentions; none opposed.
3. Reports/Announcements from the Dean - Edelma Huntley
 - Memo distributed to the UNC Graduate Council from Dr. Alan Mabe, UNC General Administration, regarding “Recommendation of a New Policy for Academic Program Planning by the Committee on Educational Planning, Policies, and Programs” – a proposal to the Board of Governors to change way in which new programs are proposed, established, and implemented. The Board of Governors will discuss the proposal on June 4. Members are asked to review the memorandum and email questions or comments to Edelma Huntley.

With the proposed policy, the Board of Governors and General Administration will issue to the 16 campuses a Request for Proposals (RFP) focused on specific topics. Proposals will be considered at other times, depending on need.
 - The Triangle Census Research Data Center is a partnership between Duke University, the US Census Bureau, and the UNC System. Appalachian faculty, staff, and graduate students now have access to large databases, but due to security, interested parties must travel to Duke to access information.
 - North Carolina Research Competitiveness Funding FY 2008-09. In 2007, the UNC System received \$3M nonrecurring funds for research competitiveness programs leading to economic development. Each institution could submit two proposals, three if inter-institutional. Last year, most awards were in the STEM disciplines. Appalachian submitted three; two were funded. The UNC System is asking the Legislature for a 2008-09 recurring appropriation of \$30M.

- The first candidate for Vice Provost for Faculty is on campus. Dr. Norma MacRae will give a presentation 4-6:00 p.m. on Tuesday, April 22. This position will work with Faculty Senate, task forces dealing with faculty rewards, the Council of Chairs, the Hubbard Center, and the Office of Research and Sponsored Programs for faculty development.

- Programs plans (vision, mission, and goals/objectives) are to be submitted before the end of the semester, reviewed over the summer, and discussed at the September meeting.
- Groups will be formed over the summer to discuss and propose policy on: 1) general graduate school policies for internship/practicum; 2) policies on graduate certificates, including dual enrollment in a certificate and a degree (i.e., double counting policies) and changing from a certificate to a degree program; 3) dual listed course policy review (i.e., do we wish to change the way courses open to

seniors and graduate students are handled?). If interested in a topic, please notify the Graduate School.

- A working group will meet over the summer to investigate additional global/international curriculum in graduate programs through "global minors," such as a Latin American Studies graduate minor.
- The Graduate School is advertising for a Director of Graduate Admissions and Recruiting. On May 1, the committee will begin review of applications.

5. Reports/Announcements from the Proposal Development Team - Pollyanne Frantz

- The Graduate Studies and Research newsletter will be published on a monthly basis and will include articles about funded faculty and funding opportunities.
- The Thomas Blackburn workshop had 19 participants; 7 received individual consultation.
- The NEH workshop with Marion Tangum will be held in late May. Day 1 will be short workshops on different NEH programs; Day 2 will be small groups working on ideas.

PSY 12. Add a PhD program in Clinical Psychology with a rural focus.

Tabled at the March meeting, this proposal is presented for permission to request authorization to plan new doctoral program.

ENG 0708/05. Add ENG 5124: Teaching Introduction to Writing Across the Curriculum as an elective.

Motion: Approve ENG 0708/05. Add ENG 5124 as an elective) with one change: The bulletin description needs to be changed to references "5124" instead of "5123."

Vote: Motion Carried. None opposed; no abstentions.

Motion: Approve FLL-07-25. Change FRE 5002. The Council requested that the department reword the bulletin description for clarity, i.e., clarify which modifiers go with "art" and "literature."

Motion: Approve PSY2 (Add PSY 5207 as an elective) with the following change and suggestion: Remove the (SPEAKING) notation from the graduate course.

C. Changing the admission requirement listed under Basic Criteria for Consideration to GREV=450, GREQ=450.

Motion: Approve LES 5, 6, and 7 (Change 3 courses, Add 4 courses, Drop 2 courses, and change the program requirements for the EdS in Educational (School Administration) with the following change:

Change: Revise LES 7 to remove the two courses from the EdS program, but *NOT* drop them from the bulletin; they are required for doctoral students in the licensure track who do not already have superintendent licensure.

Note: The Subcommittee did not approve early implementation. The effective date should be Fall 2009. They strongly oppose early implementation as registration for fall has started.

B. Delete CS 1440 Computer Science I as a prerequisite for the Master of Arts in Educational Media – Instructional Technology/Computers Major (437).*

Motion: Approve LES 8 (Split the Educational Media program (currently one major with 5 concentrations) to be Instructional Technology with two concentrations in LES and Educational Media with three concentrations in C&I)

Note: The Subcommittee did not approve early implementation. The effective date should be Fall 2009. They strongly oppose early implementation as registration for fall has started.

Vote: Motion carried. None opposed; no abstentions.

8. Faculty Development Committee -- Bill Brewer. Continued discussion of Graduate Faculty Membership

At the March meeting, there was consensus that the subcommittee draft graduate faculty credentials. Using criteria drafted by the Graduate Council, departments will define their own criteria. Proposed criteria include, but are not limited to, staying current in the discipline, effective teaching and mentoring at the graduate level, and engagement in graduate education and research.

The subcommittee will continue to discuss criteria, timing (during the regular review process), and levels of membership (if applicable).

9. Student Affairs Committee -- Sammie Garner

The Graduate Student Awards Luncheon was held April 13. Awards were given for Outstanding Thesis in the Arts and Humanities, Social Science and Education, and Science and Technology; the Domer, Lawrence, and Zigli research awards; and the Outstanding Graduate Teaching Award.

Selections are complete for the Lovill and Chancellor's Fellowships. The subcommittee will review over 90 applicants for the Provost's and Alumni Fellowships, a third more than last year.
