1. Dr. Huntley called the meeting to order.

- 2. It was moved (Valante), seconded (Killacky), and unanimously approved that the minutes of the January 28 meeting be accepted.
- 3. Announcements from the Graduate School
  - Airport interviews for the Dean of Education will be held in Charlotte on February 25-26.
  - AdmissionPros has a more user-friendly web-based application. The Graduate School is cleaning data as a result of the recent upgrade. There are over 3200 applications in the system for summer and fall +400 from this time last year. It was noted that email notifications are not being sent to the department when there are applications for review.

- English 5100, currently offered every fall, will now be offered every spring.

Where do you see graduate education in 5-10 years? What are the priorities?

- Frequent words that pop up: students, community, and faculty.
- The Graduate Council retreat activity noted that graduate education has greatly changed in the last 5 years.
- need tuition incentives and other support for graduate students; losing NC students to neighboring states
- UNC-GA mandated the review of low enrollment programs. Do we need more programs? Do we enhance those graduate programs doing well?
- need more resources for the Graduate School
- career placement for graduate students
- improve library holdings at the graduate level
- recruit students from other colleges and universities
- provide on campus graduate housing
- provide dedicated space for graduate students either within departments or a Graduate Life Center
- share research being done in programs
- provide statistical and technology support
- decide whether courses will be on campus, off-campus, online or a hybrid
- create post master's certificates of advanced study (12-18 sh)

Graduate enrollments are down nationally, increasing competition among universities. Email Scott Collier (colliersr) with additional feedback on graduate education.

# **Accelerated Admission Pilot Program**

As discussed last fall at Graduate Council, we are considering an accelerated admission program that would allow strong rising seniors to get a head start on a graduate program during their senior year. We have identified several programs for the pilot.

#### **OVERVIEW**

### Eligible students:

- 3.4 GPA
- completed 90 undergraduate hours by the end of Spring 2013 (i.e., rising seniors)

### If accepted, the students would:

- apply for admission to the graduate school for summer or fall 2014 admission, and the GRE would be waived (for the PILOT, the application fee would be waived also)
- be allowed to complete up to 12 graduate hours during their senior year 9 of which would be allowed to count toward both undergraduate and graduate degree requirements
- "roll" to graduate student standing as soon as undergraduate degree posting is complete, at which time they would then be eligible for NCTS / assistantship funding

Deadline for nominations: April 19, 2013

## Advantages:

- This program would allow us to retain some of our stronger undergrad students, and potentially increase the number of graduate students in smaller programs and in those that currently make heavy use of dual-listed courses.
- This program would allow for reduced dependence on dual-listed courses as strong seniors would take the graduate version of the course
- Students could, with careful course selection and sequencing, finish their master's program in one year post undergraduate (hence to common term 4+1 used for these programs)
- Students would pay the undergraduate tuition rate for up to 12 hours of coursework.
- Students could avoid taking the GRE, which currently costs well over \$200.

### Disadvantages:

- Students in the program who decide to complete a graduate degree elsewhere will almost certainly not be able to transfer the coursework elsewhere.
- Students will not be classified as graduate students until their undergraduate degree is posted, and so will not be eligible for graduate student funding (NCTS, assistantships)

The students and programs involved in the pilot must also agree to participate in assessment via surveys and focus groups.
