1. Call to order and welcome – Max Poole
2. Announcements
 - A. Dr. Poole recognized Mrs. Sandra Krause for seven years of service to Graduate Studies and 19 years of service to Appalachian. Mrs. Krause accepted a position at UNC-Charlotte. Her final day at Appalachian will be February 6. Until the position is filled, recruitment will be handled by Rob Sanders and Vivian Meadows, and admissions will be handled by Anna Basnight and Brenda Chambers.
 - B. Dr. Poole announced he will be on medical leave during the month of February. Dr. Rob Sanders will act as Dean during this period.

Questions/Comments :

1. On proposal AS_01: 1) why retain proficiency? Is there really a need for students to have these skills to complete the program? 2) Also, ENG 5650 is Gender Studies (not 5560 as listed).
2. On proposals AS_02 and 03, will IRB processes be addressed at some point in these courses?

- *COB-BATF-2014-01. Action requested: Create a program of study for a Master of Science in Applied Data Analytics. The program will require 36 course hours to be taken over a one year time span. 27 hours will be core curriculum (required courses) and 9 hours can be selected from approved elective options.*
- *COB-BATF-2014-02. Action requested: Set the core prepreqs for the MS in Applied Data Analytics and change core class to allow auto enroll in these classes. Admission Requirements: Baccalaureate degree from an accredited college or university; complete application to the Graduate School; official general GMAT or GRE exam scores; evidence of knowledge in statistics, financial accounting, economics, corporate finance, marketing, and organizational behavior through course work, work experience or completion of the accelerated prerequisite program before taking graduate course work in those subjects. Change the prereq for the core classes proposed for the MS in Applied Data Analytics to allow students in this program to automatically enroll in the pre-approved courses listed below.*

- *COB-BATF-2014-05. Change CIS 5850 Business Analytics Project from three (3) credit hours to a flexible (1-6) credit hours. The hours may be repeatable for credit up to 9 hours and change the course name to "Applied Analytics Project"*

Questions/Comments:

1. On proposal BATF_01, ACC/MBA 5240 and ECO 5621 are not listed correctly in the POS table. If either ACC or MBA 5240 is acceptable, then the POS should indicate “choose one of...” Also, in the sustainability analytics and interdisciplinary analytics concentrations, the following statement should be included: “Courses outside of the College of Business require approval of the department prior to registration.”
2. On proposal BATF_02, should the prerequisites for the other MBA courses in the program (5080, 5220, 5240, 5250 5680, 5999) be changed to include permission for BATF students (as indicated for some of the MBA courses)?
3. On proposal BATF_03, this proposal to add a new course should include the desired prerequisite statement (as indicated in proposal 02). Also, there are no D level grades at the graduate level.
4. On proposal BATF_05, the course number will need to be changed because the credit hours are changing to variable with a range that allows fewer hours.

Dr. Vannoy and Dr. McGann responded the comments and agreed to edits as indicated.

Questions/Comments:

1. On proposal ITC_4, ITC 5642 is being created to be “the same as” CI 5642, but is not the same (title or description) as CI 5642; is this proposal intended to change both courses? Also, the “same as” statement will be placed at the end of the description to be consistent with other course descriptions.
2. On proposal ITC_5, should the prerequisite be ITC/CI 5642? (see proposal 4 comment.)
3. On proposal ITC_6, the description should end in a period rather than a comma.
4. On ITC_9, why keep the general concentration? Who do you envision would need such an open-ended program?
5. On ITC_10, the rationale mentions “concentration” where “certificate” should be used.
6. On ITC_13, note that the bulletin will present the programs in the usual order (minor, certificate, major), and the POS table will be reformatted to be consistent with the others in the bulletin.

Discussion

1. Delete the language “the same as CI 5642” from proposal COE_LES_ITC_2014_4. ITC 5642 is not the same as the old CI 5642. CI 5642 would require updating if offered in the

revised program as it focuses on web design rather than the more broader design and development of digital media; however, CI 5642 will not be offered in the new program.

2. Concerns were addressed. Edits accepted.

VOTE 5-B: With clarifications noted above, motion carried unanimously. None opposed. No abstentions.

Question/Comments:

1. On proposal ES_3, the change to this course appears to be significant enough to warrant a new course number (title, credit, description are all changing in a more than minor way). Also, there are no D level grades at the graduate level.
2. On proposal ES_8, please verify the intended title – syllabus does not match proposal form.
3. On proposal ES_9, the edits to the admission requirements will not be listed exactly as presented. We do not include the specific graduate school requirements in a program section – they are hyperlinked instead – so that if there are changes in the future, the edits need to be made in only one location.

Response from Exercise Science:

1. Proposal 3 will be changed to ES 5623.
2. Proposal 8 title as listed on the syllabus should be changed from “Cardiorespiratory Physiology” to “Cardiovascular Physiology.”

VOTE 6: With clarifications/edits noted above, motion passed unanimously. None opposed. No abstentions.

Questions/Comments:

1. On proposal CGG_40, how often can this repeatable course be repeated for credit?
2. On proposal CGG_43, the POS table needs to be edited to include the appropriate course prefixes.
3. On proposal CGG_44, this is really a deletion of a certificate and creation of a new one, and so will need a new code (not 130A). The POS table will need to be edited to include correct prefixes, titles, and course hours.

DISCUSSION:

1. Motion amended by Dr. Hirst to include the following sentence in Proposal 40: **“May be repeated for credit if the content does not duplicate.”** Banner can be set to “99” to repeat.
2. The Registrar’s Office will assign a new code to the certificate (Proposal 44).

VOTE 7: With clarifications/edits noted above, the amended motion was approved. One opposed (Root). No abstentions.

MOTION 8: Approve the Graduate Studies policy proposal (GRD_2015_1). Note: This policy should be located under non-degree coursework and certificate program of study areas of the policy section in the bulletin, rather than in the “transfer” credit section. Transfer is used to indicate coursework taken at other universities.

GRD_2015_1. Modify the graduate Transfer of Credit policy to allow up to all hours earned toward an Appalachian certificate program to be used toward a graduate degree program in the same or related field. Limits on external transfer credit and non-degree transfer credit would remain in effect.

DISCUSSION: This change will be disseminated to Graduate Program Directors and other select staff who work with graduate students as well as the change included in the Graduate Studies’ Friday Update from Rob Sanders.

Response from Arts & Sciences and Psychology:

1. Proposal 29 will be changed to deletion of PSY 5010 and addition of PSY 5015 Research Seminar to accommodate implementation in Banner.
2. Proposal 18: If a deleted class is needed, the department will work with the student on a substitution. Correct POS to change PSY 5010 to PSY 5015.
3. PSY_24 action will be corrected with appropriate course number/title.

 - 2) *eliminate the admission requirement to submit a letter of intent addressed to the reading faculty specifying current teaching position, if applicable, teaching goals, and reasons for seeking admission to the reading program; and*
 - 3) *eliminate the admission to candidacy requirement.*

The Reading Education and Special Education (RESE) Department requests approval for changes to the list of courses for the Graduate Certificate in Reading (12 hours) -- approved 10-2014. We deleted the post-master's certificate and want to add those courses to be part of the new graduate certificate.*

Question/Comment: On Proposal RESE_20, it will be VERY important to be sure students without A licensure understand they don't get ANY sort of licensure from this program. With

two kinds of students in one program, tracking appropriately (including assigning attributes in Banner) will need to be handled in the RCOE.

Response from RESE: Dr. Koppenhaver responded that Proposal 20 was approved by the Council on Teacher Education.

1. There will be a statement in the Bulletin that A licensure is required in order to obtain M licensure.
2. At the end of the program, the student will have a Master's degree; licensure is granted by the State. This will be relayed through advising.

Dr. Hirst noted that these students will have to be manually coded in Banner.

2. On proposal 9, the words “mental retardation” are being deleted so this is also a description change (not just a prerequisite deletion).
3. On proposal 13, the number of hours is being reduced – this proposal will need to state that 5900 is being deleted and 5901 (or other number) is being added.
4. On proposal 15, as with Reading Education, it will be VERY important to be sure students without A licensure understand they don’t get ANY sort of licensure from this program. With two kinds of students in one program, tracking appropriately (including assigning attributes in Banner) will need to be handled in the RCOE.

1. On proposal IND_2, please clarify what will change regarding TEC 5555 and 5565 – are they changing to IND? Will they still be dual-listed with the IND courses? Note: TEC 5555 and 5565 will also change to IND 5555 and IND 5565.
2. On proposal IND_10, the graduate version of the course should not have the speaking designator indication.
3. On proposal GAIT_01: Revised proposal submitted which makes the appropriate changes to both the undergraduate and graduate dual-listed courses, and not just to the undergraduate course: Change TEC 4592/5592 to GRA 4592/5592 and update prerequisite on the grad level version.
4. On proposal GRAD_01, should TEC 5440 be on the POS? See the rationale from proposal GRAD_02, which adds 5440 as a new course.

- *ENV_2014_07. Add a new graduate certificate program, Environmental Management*

Dr. Chris Thaxton skyped into the meeting to discuss concerns from the Curriculum and Policy Committee as presented below.

1. On proposal ENV_03, the request is to create the dual-listed course ENV 4110/5110, and also have ENV 4110 be the same as GLY 4110, without listing GLY 4110 as dual-listed. GLY 4110 will need to be considered dual-listed as well then it is the same as ENV 4110. It appears from the syllabus that the intent is to treat ENV/GLY 4110 interchangeably.
2. On proposal ENV_06, why allow 12 hours of internship if the students cannot count more than 3 toward graduation; the students would just have to pay for more hours.
3. On ENV_07, the POS for the proposed certificate raises several serious concerns, all of which appear to stem from a desire to squeeze concepts and learning outcomes suitable for a full MS program into 12 hours of coursework.
 - There is a lack of focus that does not align with the intent of a graduate certificate. It is reasonable to have a little flexibility in course selection. This proposal, comprised of 4 credit bearing courses, requires selecting 1 course out of a list of 10 and 1 out of a list of 5. Why not start with a very focused certificate that can be leveraged as a core for a (later) full degree program?
 - This curriculum appears to be more undergraduate focused than graduate focused: 2 of the 3 required courses are dual-listed (and the third is a 0 credit course), 7 of the 10 science course options are dual-listed, and 3 of the 5 policy options are dual-listed.
 - There are discussions and graphs focused on the need for a workforce in “environmental and ecological services,” but the case is not made for this set of courses preparing the needed professionals.
 - The stated learning outcomes (and there are 7 – a large number to be addressed by 12 hours) will not all be attained by students, but will depend on which courses students select from the broad ranging list. The document even points out that outcome 7 (communication, team building...) is met by an optional course.

Dr. Thaxton indicated that the curriculum proposals followed 2.5 years of work with an external advisory group. Following discussion, Dr. Thaxton requested an itemized list of the concerns for continued discussion with the external advisory group.

VOTE 21: Motion did not pass (0 for; 5 opposed; 4 abstentions).
