- 1. **Minutes.** It was moved (Mamlin), and seconded (Thomley), that the minutes of the October 16 meeting be approved. Motion carried. No abstentions; none opposed.
- 2. **Reports/Announcements from Proposal Development Team**—Edelma Huntley reported for Pollyanne Frantz.
  - A. The Research Education Series, funded through *Transforming Campuses*, is offering its third workshop. Participants are selecting grant topics. The next workshop in the series will be agency and funding-source specific.
  - B. An online grant writing toolbox is being developed for grant writers. A research graduate assistant is consulting with the University Webmaster to link research to the University's web page.
  - C. Research development officers continue to network throughout the colleges.
  - D. Larry Kortering administered a survey in Education using a Survey Monkey subscription to determine what services faculty require. He will also survey Arts and Sciences, Fine & Applied Arts, Business, and Music in Spring.

- B. *Graduate Bulletin* Organization. The Bulletin format is under review, and feedback is requested. It is proposed that each program be listed alphabetically with program description, including department, and admission information followed by the course of study on a separate page. The addition of an Admission to Candidacy section is suggested which will list steps, such as completion of Program of Study, interview, or other departmental criteria. There was consensus that from the student point of view programs be listed alphabetically with

graduate courses listed at the back of the *Bulletin*. Council members are asked to discuss format with their colleagues and students. March is the deadline to update the *Graduate Bulletin*. Note: Editorial changes to the *Bulletin* do not require AP&P approval, however, program requirement changes (including admission criteria and all program requirements) require approval.

- C. Electronic Thesis Submission. Graduate Studies is pursuing electronic submission in \*.pdf format through the Library. Once finalized, students will submit theses as \*.pdf documents. Students will be encouraged to present bound copies to the advisor and department, but Library copies will be stored in an electronic database.

- A. Awards are up 20-23% with 150 proposals pending. Council members are encouraged to recognize October award recipients.

- C. The Federal government is moving toward electronic submission: GRANTS.GOV. Each agency has its own submission protocol. This has major implications for deadlines as proposals are submitted and reviewed through Grants.Gov then forwarded to the appropriate agency. During the review process of both Grants.Gov and the agency, error messages notify the grant writer of problems. Submission must be in a timely manner to meet agency proposal deadlines.

Over the last 5 years, the University has a 66.1% funding success rate. The hit rate with NSF is 24%. Research and Sponsored Programs what areas of need and support are required by faculty.

#### 6. **Report from Student Affairs Committee**—Sammie Garner, Chair

The Student Affairs Committee (Garner, Jackson, Monteresi, Pollard, Thomley, and Westerman) met to review applications: 3 Domer; 2 Lawrence; 10 Zigli. #### 8. Report and Recommendations from Academic Policies Committee-Holly Hirst

<u>Proposals from Accounting</u> - ACC Proposals 1 through 19 Accounting Program Deletion: Information Systems Concentration Accounting Program and Course Changes

**MOTION**: Approve the Accounting Proposals ACC 1.0607 through ACC 19.0607 with the following change to all proposals involving undergraduate prerequisites (ACC 5.0607, 6.0607, 8.0607, 11.0607, 12.0607, 13.0607, 14.0607): List undergraduate prerequisites by number and name, e.g., "ACC 4580 (Income Taxation of Corporations) or equivalent" rather than just as ACC 4580.

#### Notes:

- (1) ACC 9.0607 (changes to ACC 5990) We have confirmed with the program that last sentence of the rationale was included in error ("The course does not need the stated prerequisite"). The bulletin description presented is correct and should include "the consent of the instructor."
- (2) ACC 4.0607 (adding ACC 5990 to the program as a requirement): The bulletin description included with this proposal for information left off the prerequisite -- This course should have the same bulletin description as presented in ACC 9.0607.

**VOTE**: Motion approved. No abstentions; none opposed.

Proposals from Foreign Languages and Literatures (Spanish)

**MOTION**: Approve the Romance Languages proposals FLL 2006-1 through 2006-4

Notes: While the dual listed course syllabi clearly distinguish between the undergraduate and graduate course requirements, the Committee requests that the department representative discuss the dual listing in light of the Graduate Education Task Force recommendation to reduce dependence on dual listed courses.

Notes: (1) HPC-2 and HPC-5 course descriptions include information about the follow-on courses ("This course is a prerequisite for"), which is not standard practice.

**VOTE**: Motion approved. No abstentions; none opposed.

**MOTION**: Approve Community Counseling proposals HPC6 through HPC8 with the following correction: On the proposed program in HPC-7, correct the number for the course under "required concentration courses" for the Marriage and Family Counseling Concentration. 271 should be 5271.

Dr. Davis noted a course number is typed incorrectly on the MFT concentration. This will be corrected. These changes will align the curriculum with CACREP requirements in 2008.

Political Science Course Changes - PSCJ Proposals 1 through 4 Public Administration Program and Course Changes - MPA Proposals 1 through 7

MOTION: Approve the Political Science proposals PS/CJ-1 through PS/CJ-4

- (1) While the dual listed course syllabi clearly distinguish between the undergraduate and graduate course requirements, the Committee requests that the department representative discuss the dual listing in light of the Graduate Education Task Force recommendation to reduce dependence on dual listed courses.
- (2) The course numbers listed on the syllabi for PS/CJ-2 and PS/CJ-4 are incorrect. The course numbers listed on the proposals are correct.

**MOTION**: Approve the Public Administration proposals MPA 2006-1, MPA 2006-2, MPA 2006-5, MPA 2006-6, with the following changes: On the proposed course titles for MPA 2006-1 the title for PA 5460 should be "Budgeting and Fiscal Administration" (i.e., remove the word "Public"). Add to the proposed course titles for MPA 2006-1: PA 5530-5549 Selected Topics and PA 5500 Independent Study (left off in error).

Notes: The Committee will present its motion on the proposals MPA 2006-03, MPA 2006-04, and MPA 2006-07 at the Council meeting. The Committee's concern is based upon the creation of a capstone research course 5558 (MPA 2006-04) that would be corequisite with the existing capstone course also undergoing some revision (MPA 2006-03). The course outline for 5558 lists requirements for the entire year for a course offered for one semester, i.e., there are explicit requirements that must be met before of the official semester of enrollment. We are in discussion with the program about this, and hope to have resolution by the Council meeting on Monday.
