The recommendations from the February 19, 2014 Academic Policies and Procedures Committee meeting are approved. "I have met with Chancellor Peacock and we affirm the recommendations in VOTES #3 (Eliminate MA in Music Education) and #12 (Eliminate MA in Gerontology.) We accept the recommendations in VOTES #2 (Consolidation of Business Education, Family & Consumer Science and Technology Education into a single program, Career & Technical Education.) and #9 (Allowing the Master of Arts in Romance Languages to continue for two years.) Other recommendations in the December 16, 2013, Academic Program Prioritization plan will stand as presented. These recommendations include elimination of the following programs: Master of Arts in History, Education; Master of Arts in Child Development: Birth through Kindergarten; and Master of Sciences in Criminal Justice & Criminology. We recommend this program become a concentration in the Master of Public Administration degree program."
