### NEW BUSINESS:

Dr. Richard Henson presented proposals from the College of Arts and Sciences for the Departments of Interdisciplinary Studies; and Philosophy & Religion.

Proposals IDS 1 and IDS 2 from the Department of Interdisciplinary Studies were approved as follows (EFF. FALL, 2005):

# 1. <u>Course additions</u>:

# IDS 5100. Foundations of Sustainable Development/(3).F.

This course presents a broad foundation in sustainable development. It demonstrates the transdisciplinary and polymethodic character of sustainable development, and provides an introduction to the relevance of a variety of disciplines, such as economics, bio-physical sciences, ethics, appropriate technology, cultural anthropology, and planning to this transdisciplinary nexus. Students will also be introduced to the significance of method in generating knowledge, and to the challenges involved in integrating information generated by means of differing methods. Students will explore the foundations of sustainable development historically, economically, scientifically, and cross-culturally. Students will be introduced to professional opportunities in sustainable development and begin research in internship opportunities.

# IDS 5300. Issues in Global Systems Science/(3).S.

This course involves an examination of the nature of science in relation to sustainability, including scientific method and various methods of investigation, data collection, analysis, and presentation; basic principles of science including time, change, space, and energy; biological issues such as population growth and carrying capacity, deforestation, decreasing biodiversity, and changing ecosystems; geological issues such as coastal flooding associated with global warming, resource depletion, and chemical pollution of water and soils; and meteorological and climatological issues such as ozone depletion, and climate change, including global warming. Prerequisites: A one-year sequence of General Science, Biology, or Chemistry, plus one sophomore or higher level course in environmental science, or the equivalent of these.

# P&R 3720. Study Tour Abroad/(3-6).On Demand.

An intensive, on-site study tour of a select country or region. Specific focus will be placed on the study of the country's religious history and examination of archaeological and material artifacts. Locations include, but are not limited to, Israel and Jordan, Italy, Greece, Turkey, and Egypt. Students will incur the cost of the trip and other related expenses. Proposals Music #1-0405 and Music #2-0405 were approved as amended as follows (<u>EFF. FALL, 2005</u>):

 Approve MUS 1100 for <u>CORE: PHYSICAL ACTIVITY/WELLNESS</u> credit, and change the course description to read as follows: <u>MUS 1100. Marching Band/(0-1).F.</u> Marching Band is a performance-based course presenting musical artistry combined with complementary visual elements. The band performs at home football games, parades, pep rallies and represents the University at special ceremonies and events. Open to students with prior band experience. The band begins rehearsals one week prior to the opening of Fall semester. Rehearsal five hours, one dress rehearsal before each game. May be repeated for

credit. (CORE: PHYSICAL ACTIVITY/WELLNESS)

 Revise the course requirements for the <u>Bachelor of Music degree in Performance</u> (554\*/50.0903) with a concentration in Voice (554Y) by: (1) specifying "movement" courses, 2 s.h. selected from approved Core:Physical Activity/Wellness courses; (2) including 2 s.h. of MUS 3052, Alexander Technique (1 s.h. + 1 s.h.); and (3) reducing Free Electives from 10 s.h. to 8 s.h. (The total number of hours required for this degree, 122 s.h., did not change.) The revised catalog description will read as follows:

**The Bachelor of Music degree in Performance** is offered in the following concentrations: **Voice.** A minimum of 64 semester hours of music in the following areas: music history and theory, 24 semester hours (MUS 1001-MUS 1002-MUS 1007-MUS 1008, MUS 2001-MUS 2002-MUS 2007-MUS 2008, MUS 3002, MUS 1611, MUS 2611, MUS 2612, MUS 3611); applied principal 16 semester hours; ensembles eight semester hours; MUS 1040-MUS 1041, MUS 1045-MUS 1046, MUS 2040-MUS 2041, MUS 3020, MUS 3052 (2 s.h.), MUS 3631, MUS 3632, and MUS 4035. Required courses from other departments (not included in the 64 hour major) are GER 1010-GER 1020; FRE 1010-FRE 1020; 2 semester hours of movement courses (DAN 1400, DAN 1410, DAN 1420, DAN 2400, DAN 2410, DAN 2420; or PE 1030 and one course selected from PE 1018-PE 1050. (MUS 1001-MUS 1002-MUS 1007-MUS 1008 and MUS 2001-MUS 2002- MUS 2007-MUS 2008 require a minimum grade of C-.)

Proposals Music #6-0405 through Music #13-0405 were approved as amended as follows (<u>EFF. FALL, 2005</u>):

1. Add a <u>Master of Music Therapy (MMT) degree (CIP 51.2305</u>). [CONTINGENT UPON APPROVAL FROM THE UNIVERSITY OF NORTH CAROLINA'S OFFICE OF THE PRESIDENT.] (The total number of hours required for the MMT degree will be 36 s.h.) (NOTE: Copies of the graduate catalog description are on file in the Office of Academic Affairs, and in the Graduate School office.)

# 2. <u>Course additions</u>:

<u>MUS 5050. Supervision and Collegiate Teaching in Music Therapy/(2).On Demand.</u> Exploration of issues in undergraduate preparation of music therapists. Prerequisite: MUS 4900, Music Therapy Internship, or equivalent. Students must be enrolled concurrently in MUS 5200, Music Therapy Laboratory.

#### MUS 5051. Advanced Topics in Music Therapy/(3).On Demand.

Investigation and examination of current trends, especially those related to advanced clinical practice in music therapy, including client assessment through music experiences and innovative treatment methods. Prerequisite: MUS 4900, Music Therapy Internship, or equivalent. Students must be enrolled concurrently in MUS 5200, Music Therapy Laboratory.

# MUS 5060. Guided Imagery and Music, Level I/(3).SS.

Through lectures, demonstrations, and supervised experiences as guide and traveler, this introductory level training will provide participants with a basic understanding of the components of The Bonny Method of Guided Imagery and Music (GIM) process. Prerequisite: A GIM personal session. (Note: MUS 5060 requires participation in a 5-day intensive workshop that is conducted off-campus between academic terms and requires payment of workshop fees in addition to tuition.)

#### MUS 5061. Advanced Clinical Improvisation/(3). On Demand.

Theory and practice of advanced techniques for clinical music improvisation. Prerequisite: MUS 4060, Clinical Piano Improvisation, or equivalent. Students must be enrolled concurrently in MUS 5200, Music Therapy Laboratory.

# MUS 5200. Music Therapy Laboratory/(0).F;S.

Music improvisation-based laboratory designed to provide direct experiences as a participant in a music therapy group. Prerequisite: Bachelor's degree in music therapy, or 5 s.h. of MUS 3900, Music Therapy Practicum. Required of all music therapy graduate students. Graded on an S/U basis. Laboratory one hour.

#### MUS 5900. Advanced Music Therapy Practicum/(1-3). On Demand.

In-depth clinical experience designed to broaden clinical skills or provide opportunity for application of advanced music therapy methods. Prerequisite: MUS 4900, Music Therapy Internship, or equivalent. Students must be enrolled concurrently in MUS 5200, Music Therapy Laboratory.

# MUS 5996. Creative Project in Music Therapy/(4).F;S.

Execution and scholarly documentation of research based clinical project. Graded on an S/U basis.

<u>NOTE: Policy Regarding Department Name Changes:</u> "Name changes may be presented to the AP&P Committee for discussion at the discretion of the Provost and Executive Vice Chancellor for Academic Affairs; however, this is not mandatory. Authority for name changes rests with the Chancellor." (Oct. 1988 AP&P Minutes)
