# MINUTES OF THE MEETING <br> OF THE ACADEMIC POLICIES AND PROCEDURES COMMITTEE <br> November 3, 1999 

The Academic Policies and Procedures Committee held its regular monthly meeting on Wednesday, November 3, 1999 in Room 224 of I.G. Dr. Parker noted that the October 6, 1999 minutes are not being considered for approval today. They will be distributed as soon as possible.

Dr. Brett Everhart presented proposals from the College of Fine and Applied Arts for the Department of Health, Leisure and Exercise Science. Proposals PE \#1-4 were approved as amended as follows (EFF. FALL, 2000):

1. Course additions:

## PE 3005. Theories and Concepts of Teaching Physical Education in the Elementary School/(3).F;S.

This course will focus on the teaching of skills to comply with the requirements established by the NC Standard Course of Study for grades K-8. Pedagogical concepts will be applied while teaching activities to peers, to public and private school students, and/or to home schooled students. Prior to the teaching experiences, students will be required to fulfill observation hours in the selected schools. The course will be conducted in a seminar fashion in order to relate theoretical concepts with practical experiences. Students will be video taped by peers in a lab setting, and required to utilize web sites to collect data for teaching portfolios.

## PE 4553. Women and Sport/(3).F.

A study and analysis of sport from a feminist prospective and its impact on women's participation in sport.
2. Course deletion:

PE 3011. Games, Gymnastics and Dance for Children/(3).F;S.
3. Revise the course requirements for the B.S. degree in Physical Education, K-12 with teacher licensure (568A/13.1314)[T] by deleting PE 3011; and by adding PE 3005 as a required course. (The total number of hours required for the degree, 128 s.h., did not change.) (NOTE: A copy of the catalog description is on file in the Office of Academic Affairs.)

1. Change the name of the Department of Finance, Insurance and Real Estate (FIR) to the Department of Finance, Banking and Insurance (FIN). (CONTINGENT UPON APPROVAL OF CHANCELLOR FRANCIS T. BORKOWSKI.)

2. Change the prefix on all courses taught in the Department of Finance, Banking and Insurance from FIR to FIN. CIS 3010. Microcomputers in Business/(3).F;S.
An examination of the role of microcomputers in business firms and the managerial issues in end user computing. Emphasis will be placed on the design, implementation and definition of the role of the microcomputer in information systems, evaluation of hardware and software and the management of micro-information systems. Prerequisite: CIS 1025 or equivalent. (COMPUTER)

Proposal MGT \#1 from the Department of Management was approved as follows
(EFF. FALL, 2000):

1. Change the title and course description of MGT 4700, Organization Theory, as follows: MGT 4700. Contemporary Issues in Management and Leadership/(3).F;S.
This course is designed to explore theories and practical applications of management and leadership in organizational settings. The major emphasis is on building the managerial and
leadership skills necessary to diagnose and provide remedies for organizational level problems. Subjects covered include: management, leadership, strategic vision, organizational culture and values, motivation and empowerment, teams, leading diversity, and leading organizational change. Prerequisite: MGT 3630 or 3010.

One proposal, MBA \#1, for the Master of Business Administration was approved as follows (EFF. SPRING, 2000):

Dr. Faye Sawyer presented proposals from the College of Arts and Sciences for the Departments of Chemistry; History; Political Science/Criminal Justice; and Sociology and Social Work.

One request from the Department of Chemistry was approved as follows (EFF. FALL, 2000):

1. Separate the listings for lecture and laboratory in CHE 2201 and 2202 as follows:

Change the credit hours from 4 s.h. to 3 s.h., change the course descriptions, and the prerequisites/corequisites for CHE 2201 and 2202, and ADD CHE 2203 and 2204.
CHE 2201. Organic Chemistry I/(3).F;S.
A study of the fundamental concepts and basic physical and chemical properties of the major classes of the compounds of carbon. Structure and reaction mechanisms will be introduced in relation to these properties and concepts. Prerequisites: CHE 1102 and 1120. Corequisite or prerequisite: CHE 2203. Lecture three hours.

## CHE 2202. Organic Chemistry II/(3).F;S.

An in-depth study of the structure, stereochemistry, and reactions of the major classes of organic compounds. Reaction mechanisms and spectroscopy will be emphasized.
Prerequisite: CHE 2201 with a grade of C- or higher and CHE 2203. Corequisite or prerequisite: CHE 2204. Lecture three hours.
2. Approve CHE 2204 for the $\mathbf{W}$ (WRITING) special designator; and delete the $\mathbf{W}$ (WRITING) special designator from CHE 2202.
3. Course additions:

CHE 2203. Organic Chemistry Laboratory I/(1).F;S.
Laboratory practice in techniques and class reactions. Laboratory three hours. Corequisite or prerequisite: CHE 2201.

## CHE 2204. Organic Chemistry Laboratory II/(1).F;S.

Laboratory practice in synthesis, modern separations, practical spectroscopy, and determination of unknowns. Prerequisite: CHE 2201 with a grade of C- or higher and CHE 2203. Corequisite or prerequisite: CHE 2202. Laboratory three hours. (WRITING)

An introduction to the development of world civilizations from ancient times to 1500 . The unique patterns of political, intellectual, economic, and social development of Europe, Asia, and Africa are examined. (MULTI-CULTURAL) (CORE: SOCIAL SCIENCES)

## HIS 1102. World Civilization II/(3).F;S.

An introduction to the development of world civilizations from 1500 to the present. The development of an increasingly interdependent political, intellectual, economic, and social world is examined. (MULTI-CULTURAL) (CORE: SOCIAL SCIENCES)

HIS 3724. History of the American West/(3).F. "W"

Proposal \#CJ99-1 from the Department of Political Science/Criminal Justice was presented FOR INFORMATION ONLY:

1. Add a Graduate Certificate Program in Criminal Justice comprised of 18 semester hours of graduate level criminal justice course work. (NOTE: A copy of the "Guidelines for Graduate Certificate Programs at ASU" which were approved at the April 19, 1999 Graduate Council meeting are on file in the Office of Academic Affairs.)
[Dr. Dennis Grady explained that the Criminal Justice Graduate Certificate Program has been developed specifically to meet the needs of community college instructors who are required to have 18 hours of course work in their field of study in order to teach at the community college level. The certificate program utilizes existing CJ courses which are offered primarily through the NC Information Highway distance education, videoconferencing technology. Dr. Grady noted that the certificate program will not be listed in the Graduate Bulletin because once it has served its purpose, then it will no longer be necessary to offer the program. Dr. Parker noted that this is not a degree program - it is a certificate program created for a very specific purpose. Students will receive a certificate of completion by the department offering the GCP, and the student's transcript will reflect the 18 s.h. of graduate level course work, and the transcript will note that the certificate has been earned.]

Proposals SOC/SW-991 and 992 were presented from the Department of Sociology and Social Work. Following the discussion and questions regarding proposal SOC/SW-992, a motion was approved to table this proposal until the next meeting. The committee members asked that Dr. Allie Funk attend the next meeting to address concerns regarding the proposed new course, SOC 3320, Sociology of Conflict Resolution.
