This course examines philosophical approaches to disability and philosophical engagements with the interdisciplinary field of disability studies. Topics addressed include, but are not limited to, the meaning of disability and ability, disability identity and experience, the normal and the

abnormal, personhood, health, and the entanglement of ableism with other systems of oppression (e.g., sexism, racism, homophobia, and transphobia).

The department name and abbreviation - Center for Appalachian Studies (AS) will be removed in Banner. The department name and abbreviation for Appalachian Studies programs will be Interdisciplinary Studies (IDS).

The course prefix and its description will remain (AS) - Appalachian Studies.

For catalog and Banner (Student Records & Student Curriculum) purposes, this reorganization is Effective: Fall 2021 (for the 2021-2022 undergraduate and graduate bulletins.)

For budgeting and contract purposes, the Effective date is July 1, 2021.

Note: Beginning language course I & II or beginning combination language course and intermediate language course I are prerequisites for *intermediate level II course. Placement

tests are designed for placement purposes only and a score on this test alone is not sufficient to demonstrate intermediate-level proficiency.

Language courses 1050 or 1060 may be used in General Education Liberal Studies Experience.
