U UC US 2020 1

Change the course prefix, course number and semester offering of RE 1010 – Power Reading (1) [DELETE RE 1010 and ADD US 2002] and move from Reich College of Education to University College to read as follows:

# U S 2002 - Power Reading (1)

When Offered: Fall; Spring; On Demand.

This course is an elective course designed to provide college students with strategies and applied practice to read different types of texts as efficiently as possible. Effective readers must adjust and adapt their reading speed and strategies to fit the purpose of the reading. Students practice methods to scan and skim as well as reading comprehension strategies to help them when they need to read closely to retain more complex material.

U S 2002 may be repeated for a total credit of two semester hours.

RE 1010 and US 2002 are equivalent.

Clarify the residency requirement policy in the Bulletin to reflect UNC Online courses and that they do NOT count in the residency requirement to read as follows:

With some exceptions, coursework is defined as "in residence" when registration is through the University. The physical location at which the course is delivered, whether in Boone or through a field-based program, does not affect this definition. The following types of courses, however, are not considered "in residence": transfer credit, including courses taken through UNC Online, credit by examination, credit for life experience, credit for military experience, credit while enrolled in a non-degree status, and "institutional" credit.

To graduate from Appalachian, an undergraduate student must complete the following in residence:

- 1. a minimum of eighteen (18) semester hours in the major and (if applicable) nine (9) semester hours in the minor; and,
- 2. at least 25% of the credit hours required for the degree.

Individual academic programs may specify particular courses that must be taken in residence. A student who intends to transfer coursework from other collegiate institutions should consult the program of study for her or his intended degree program.

Walker College of Business majors must complete in residence at least fifty percent of the business coursework required for the BSBA degree.

Questions about residence requirements should be directed to the dean of the college/school under which the degree program is offered.

EDU 2000 - Introduction to Learners, Teachers, and Schools (3)

When Offered: Fall; Spring; Summer Session

As the initial course in the College of Education Core, the purpose of this course is to guide prospective teachers as they explore, examine, and critique the complex relationships among learners, teachers, schools, and educational structures. This course is designed to provide students with fundamental skills and knowledge to recognize teaching and learning as socially-constructed and context-bound experiences. Ten hours of clinical experience is required.

A minimum grade of "C" (2.0) must be earned by Teacher Education majors. Must be taken prior to admission to Teacher Education.

# **EDU 2100 - Foundations of Educational Equity (3)**

When Offered: Fall; Spring; Summer Session
An interdisciplinary course within the Teacher Education
Professional Core designed to help students develop a critical
perspective on public schooling and its socioeconomic, political,
cultural and historical role in society. The course focuses on ways in
which schools can and must engage with and support all students,
and how components of identity and positionality, such as gender,
social class, race and ethnicity, and sexual orientation, affect our
educational experiences and trajectories. The course draws on
findings and methods from philosophy, sociology, anthropology,
history, economics, psychology and political science. Frameworks
from these arenas can be used to critically consider issues of equity
and inclusion in classrooms, ideally culminating in the cultivation of
learning spaces dedicated to democracy, human dignity, and
agency.

A minimum grade of "C" (2.0) must be earned by Teacher Education majors. Must be taken prior to admission to Teacher Education.

#### Course Addition:

#### EDU 3000 - Diverse Learners: Teaching and Learning! (3)

When Offered: Fall; Spring; Summer Session

Classrooms are dynamic spaces where teachers and students with a range of identities and experiences come together to learn in community. Students will utilize a variety of pedagogical strategies to assist in the development of meaningful relationships in the classroom by reflecting on their own experiences/identities and learning about their students and their families. Students explore a range of research-based approaches to provide culturally relevant and inclusive instruction. Emphasis will be placed on understanding teaching and learning from an ecological systems perspective that takes into account individual, family, school, and broader sociocultural and political factors. Forty (40) hours of clinical experience is required. (Lab registration required). Course should not be taken concurrently with EDU 3100-

Assessment for Learning. A minimum grade of "C" (2.0) must be earned by Teacher Education majors.

Prerequisite: admission to Teacher Education is required.

U COE 2020 5 Course Addition:

EDU 3100 - Assessment for Learning (3)

When Offered: Fall; Spring

Students will critically examine factors that influence assessment practices and policies in agencies, districts, schools, and classrooms. They will consider how formative and summative data can be used to evaluate student learning, improve teacher instruction, and provide avenues for justice, equity and inclusion. They will analyze and design a variety of developmentally and culturally appropriate assessments for student learning. Teacher candidates will explore accountability systems and how the results of assessment data inform instructional decisions. Twenty (20) hours of clinical experience is required. This course is taken in conjunction with major specific program course(s). Course should not be taken concurrently with EDU 3000- Diverse Learners: Teaching and Learning. A minimum grade of "C" (2.0) must be earned by Teacher Education majors.
